- * Any vendor requiring more than 25feet **MUST** contact us for special permission before Registration is sent in.

Setup begins Friday at 8:00 a.m.

- * Personal checks will be accepted until June 15, 2026. After that date, payment must be made by Money order or cash.
- * **Refunds: No refunds will be given for early departure. No refunds will be given to “no shows”.**
- * Items prohibited for sale include: silly string, fireworks, pornographic or vulgar items, items containing racial or ethnic slurs, spray paint, nudes, glass beverage containers, firearms or other weapons. The festival committee reserves the right to restrict the sale of any questionable item. Vendors will be monitored for counterfeit items such as t-shirts, sunglasses etc. The manufacture or selling of counterfeit clothing or merchandise is prohibited by Federal and Kentucky state law.
